MINUTES OF THE 1st. BIENNIAL CONGRESS HELD ON JANUARY 27, 1988 AT ASHOK HOTEL, NEW DELHI, INDIA.

1. The President called the meeting to order at 2:00 P.M.

2. The minutes of the 2nd. Org. Meeting was read and approved upon motion by Dr. Walker and seconded by Dr. Kakar.
3. The first item taken up in the minutes was that of the annual dues. After considerable discussion, the annual fee per country of U.S.\$50 was agreed upon. Dr. Miyahara promptly gave U.S.\$100. The cost is quite small in running the organization at present. At this amount, other Asian-Pacific countries should be able to join and ensure the viability of the group. At this juncture, APEC's President, Dr. Vizcarra, humbly mentioned that he has been personally sacrificing time, effort and money in the organization of APEC. He expressed his gratitude to other members for their support and his efforts have already bore fruits with the formation of the Indian Endodontic Society.

The remaining seats for two Councillors were filled up with the election of Dr. John Booth and Dr. Atsumu Miyahara.

The Constitution and By-laws was formally ratified with the signing of all members present.

4. The brief reports from each members on the practice of Endodontics in their respective countries was reflected in the Journal published by the Indian Endodontic Society. Only Dr. Miyahara, upon his request, was allowed to read his report.
5. Next meeting was announced and set for 1989 in Seoul, Korea. Each member shall be notified of the details in due time.
6. The meeting was adjourned at 3:15 p.m.
